DESIGN GUIDELINES FOR FINAL PAPERS PRESENTATION

The final papers are to be submitted in accordance with the following design guidelines:

1. Articles must be between 12 and 25 pages in length, in the following format: 1.5 line spacing, Times New Roman size 12 font, A4 pages. All pages must be numbered consecutively, including the cover and references. Margins: 1.5 cm right, 2.5 cm left, 2.5 cm top, 2 cm bottom.

2. Any reviews must start with a complete bibliographic reference for the book to be reviewed (author, title, publishing house, place and date of publication, number of pages).

3. Bibliographic references must be included in the body of the paper in the following format: (Author[s], year: page). If referencing the same author(s) more than once for the same year, please distinguish between the citations in the following manner: First work: (Author[s], year a: pages); Second work: (Author[s], year b: pages); Third work: (Author[s], year c: page). Internet citations must mention author (if the information is available), year: page; if some of the information is not available, mention the webpage and the date of access. For information that does not have an author, such as that found in the press, use the following format: periodical, abbreviated date, page, and section.

4. The references for the bibliographical citations must be included at the end of the text, in the following format: Books: Author(s) (year of publication), Title, place of publication, publishing house, pages.

Chapters in collective works: Author(s) (year of publication), "Title", in, compiler(s) or editor(s), Title of the collective work, place of publication, chapter pages.

Journal papers: Author(s) (year of publication), "Title", journal name, place of publication, volume or tome, issue, pages of the paper. Volume must be abbreviated v.; tome, t; issue, No., and page/pages: p./pp. Internet citations must mention author (if the information is available), web page and date of access. When citing information from periodical for which there is no author given, do so as follows: Name of the periodical, abbreviated date, Title of the piece, city, country. When citing a source by an institutional author: Full name of the institution, abbreviation (if well known), (Year), Title, and Country.

5. Textual citations within the body of the text and longer than five lines (taken from books, journals, periodicals, documents, witness reports, interviews, etc.) must be in size 10, in a separate paragraph with a 1 cm indentation.

Please be advised that failure to comply with the above guidelines shall be deemed grounds for the rejection of the submission.
