## **I. Opening of the session**

(Agenda item 1)

1. The eighth session of the Ad Hoc Working Group on Further Commitments for Annex I Parties under the Kyoto Protocol (AWG-KP) was held at the Maritim Hotel, Bonn, Germany, from 1 to 12 June 2009.
2. The Chair of the AWG-KP, Mr. John Ashe (Antigua and Barbuda) opened the session and welcomed all Parties and observers. He also welcomed Mr. Harald Dovland (Norway) as Vice-Chair of the AWG-KP.

## **II. Organizational matters**

(Agenda item 2)

### **A. Adoption of the agenda**

(Agenda item 2 (a))

3. At its 1<sup>st</sup> meeting, on 1 June, the AWG-KP considered a note by the Executive Secretary containing the provisional agenda and annotations (FCCC/KP/AWG/2009/6).
4. At the same meeting the agenda was adopted as follows:
  1. Opening of the session.
  2. Organizational matters:
    - (a) Adoption of the agenda;
    - (b) Organization of the work of the session.
  3. Consideration of further commitments for Annex I Parties under the Kyoto Protocol:
    - (a) Proposal for amendments to the Kyoto Protocol pursuant to its Article 3, paragraph 9;
    - (b) Proposals by Parties on issues outlined in the work programme of the Ad Hoc Working Group on Further Commitments for Annex I Parties under the Kyoto Protocol.
  4. Consideration of information on potential environmental, economic and social consequences, including spillover effects, of tools, policies, measures and methodologies available to Annex I Parties.
  5. Other matters.
  6. Report on the session.

### **B. Organization of the work of the session**

(Agenda item 2 (b))

5. The AWG-KP considered this sub-item at its 1<sup>st</sup> meeting, on 1 June. The Chair proposed that agenda sub-items 3 (a) and 3 (b) be considered together. The AWG-KP agreed to proceed according to this proposal.

6. The Chair recalled that the AWG-KP had agreed<sup>1</sup> to forward the results of its work to the fifth session of the Conference of the Parties serving as the meeting of the Parties to the Kyoto Protocol (CMP) with a view to their adoption and that the text of proposed amendments to the Kyoto Protocol must be communicated to Parties by 17 June 2009, if Parties wish to be able to adopt any such amendments at CMP 5. He also noted that the AWG-KP had agreed<sup>2</sup> to adopt conclusions on the contribution of Annex I Parties, individually or jointly, consistent with Article 4 of the Kyoto Protocol, to the scale of emission reductions to be achieved by Annex I Parties in aggregate.

7. Statements were made by representatives of 26 Parties, including one speaking on behalf of the Group of 77 and China, one on behalf of the Alliance of Small Island States (AOSIS), one on behalf of the Umbrella Group, one on behalf of the African Group, one on behalf of the European Community and its member States and one on behalf of the least developed countries (LDCs).

### **III. Consideration of further commitments for Annex I Parties under the Kyoto Protocol**

(Agenda item 3)

#### **Proposal for amendments to the Kyoto Protocol pursuant to its Article 3, paragraph 9**

(Agenda item 3 (a))

#### **Proposals by Parties on issues outlined in the work programme of the Ad Hoc Working Group on Further Commitments for Annex I Parties under the Kyoto Protocol**

(Agenda item 3 (b))

##### 1. Proceedings

8. The AWG-KP considered these sub-items at its 1<sup>st</sup> meeting, on 1 June, and at its 2<sup>nd</sup> meeting, on 12 June. It had before it documents FCCC/KP/AWG/2009/5, FCCC/KP/AWG/2009/7, FCCC/KP/AWG/2009/8, FCCC/KP/AWG/2009/MISC.8 and Add.1, FCCC/KP/AWG/2009/MISC.9 and Add.1 and 2, FCCC/KP/AWG/2009/MISC.10, FCCC/KP/AWG/2009/MISC.11 and Add.1 and FCCC/KP/AWG/2008/8.

9. At its 1<sup>st</sup> meeting, on a proposal by the Chair, the AWG-KP decided to establish three contact groups to consider the following issues:

- (a) Issues identified in paragraph 49 (a) and (b) of the report of the AWG-KP on its resumed sixth session,<sup>3</sup> to be co-chaired by Mr. Leon Charles (Grenada) and Ms. Gertraud Wollansky (Austria);
- (b) Other issues identified in paragraph 49 (c) of the report of the AWG-KP on its resumed sixth session, to be chaired by Mr. Dovland;
- (c) Legal matters, to be co-chaired by Ms. Sandea de Wet (South Africa) and Mr. Gerhard Loibl (Austria).

10. The Chair reminded delegates that, at its seventh session, the AWG-KP had requested<sup>4</sup> its Chair to prepare a proposal for amendments to the Kyoto Protocol pursuant to its Article 3, paragraph 9, as well as a text on other issues outlined in the report on its resumed sixth session. These are contained in

documents FCCC/KP/AWG/2009/7 and FCCC/KP/AWG/2009/8, respectively. The contact groups were asked to use the two texts as a basis for their work, with a view to streamlining and further developing and refining the options contained therein.

11. At the 1<sup>st</sup> meeting, a representative of the Intergovernmental Panel on Climate Change (IPCC) reported back to the AWG-KP on the outcome of an IPCC expert meeting on the science of alternative metrics, held in Oslo, Norway, from 18 to 20 March 2009. Statements were made by representatives of five Parties. Statements were also made on behalf of the environmental non-governmental organizations (ENGOS) and the business and industry non-governmental organizations (BINGOs).

12. At the 2<sup>nd</sup> meeting, the co-chairs and Chair reported on the work of the contact groups referred to in paragraph 9 above. The AWG-KP was informed of non-papers resulting from the work of the contact groups referred to in paragraph 9 (a) and (b) above. Statements were made on behalf of ENGOS, BINGOs, and the women and gender non-governmental organizations.

13. Also at the 2<sup>nd</sup> meeting, the Chair of the AWG-KP informed delegates of informal consultations he had conducted to prepare draft conclusions under these agenda items, taking into consideration input provided to him by the chair and co-chairs of the contact groups referred to in paragraph 9 (a) and (b) above. The AWG-KP considered and adopted conclusions<sup>5</sup> proposed by the Chair.

## 2. Conclusions

14. In accordance with its work programme and its conclusions adopted at its resumed sixth session and its seventh session, the AWG-KP considered:

- (a) The scale of emission reductions to be achieved by Annex I Parties in aggregate;
- (b) The contribution of Annex I Parties, individually or jointly, consistent with Article 4 of the Kyoto Protocol, to the scale of emission reductions to be achieved by Annex I Parties in aggregate.

15. The AWG-KP also considered other issues identified in paragraph 49 (c) of the report on its resumed sixth session.

16. The AWG-KP took note of the views and proposals submitted<sup>6</sup> by Parties as follows:

- (a) Further views and proposals relating to a proposal for amendments to the Kyoto Protocol pursuant to its Article 3, paragraph 9, and a text on other issues outlined in document FCCC/KP/AWG/2008/8;
- (b) Views on possible improvements to emissions trading and the project-based mechanisms;
- (c) Views on the coverage of greenhouse gases, sectors and source categories, common metrics, possible approaches targeting sectoral emissions and other issues;
- (d) Views on options and proposals for addressing definitions, modalities, rules and guidelines for the treatment of land use, land-use change and forestry (LULUCF).

17. The AWG-KP also took note of documents FCCC/KP/AWG/2009/7 and FCCC/KP/AWG/2009/8 containing, respectively, a proposal for amendments to the Kyoto Protocol pursuant to its Article 3, paragraph 9, and a text relating to issues outlined in paragraph 49 of document FCCC/KP/AWG/2008/8.

18. The AWG-KP welcomed the exchange of views among Parties on the issues referred to in paragraphs 14 and 15 above. It agreed to continue discussions on these issues at its informal meeting on 10–14 August 2009.

19. The AWG-KP invited its Chair to prepare, under his own responsibility, documentation to facilitate negotiations among Parties, building upon the work of the AWG-KP at its eighth session, on:

- (a) Proposed amendments to the Kyoto Protocol pursuant to its Article 3, paragraph 9;
- (b) Other proposed amendments to the Kyoto Protocol;
- (c) Draft decisions on other issues identified in paragraph 49 (c) of document FCCC/KP/AWG/2008/8.

20. The AWG-KP recognized that the documentation referred to in paragraph 19 above:

- (a) Shall reflect proposals, views and discussions by Parties in a comprehensive manner;
- (b) Does not prejudice the content of the outcome of negotiations undertaken in the context of the AWG-KP in responding to decision 1/CMP.1;
- (c) Does not reflect consensus among Parties with regard to the possible contents, form or structure of the results of the work of the AWG-KP and their subsequent adoption by the CMP at its fifth session;
- (d) Does not constitute a text for proposed amendments to the Kyoto Protocol to be communicated to the Parties by the secretariat in accordance with Article 20, paragraph 2, or Article 21, paragraph 3, of the Protocol.

21. The AWG-KP encouraged Parties to share, before its informal meeting on 10–14 August 2009, views on the possible need for information and data to facilitate Parties' understanding of the implications of the options for the treatment of LULUCF discussed and considered at its eighth session. The AWG-KP invited Parties to submit relevant information to the secretariat on a voluntary and informal basis, and requested the secretariat to make this information available on the UNFCCC website.

22. The AWG-KP agreed that the consideration of the documentation referred to in paragraph 19 above at future sessions should be undertaken in line with the iterative nature of its work programme.

23. It requested its Chair to revise this documentation for each of its sessions and resumed sessions, drawing on the discussions among Parties at these sessions and in the informal meeting of the AWG-KP in August. The AWG-KP agreed to consider such revised documentation and any further relevant submissions made by Parties at its ninth session and requested the secretariat to make the revised documentation available at least three weeks before its ninth session.

#### **IV. Consideration of information on potential environmental, economic and social consequences, including spillover effects, of tools, policies, measures and methodologies available to Annex I Parties**

(Agenda item 4)

##### 1. Proceedings

24. The AWG-KP considered this item at its 1<sup>st</sup> meeting, on 1 June, and at its 2<sup>nd</sup> meeting, on 12 June. It had before it documents FCCC/KP/AWG/2009/5, FCCC/KP/AWG/2009/MISC.12 and FCCC/KP/AWG/2008/8.

25. At its 1<sup>st</sup> meeting, the AWG-KP agreed to establish a contact group to consider this item, to be co-chaired by Mr. Mama Konaté (Mali) and Mr. Paul Watkinson (France).

26. At the 2<sup>nd</sup> meeting, statements were made on behalf of the indigenous peoples organizations and the trade union non-governmental organizations.

27. At the same meeting, the co-chairs reported on the work of the contact group referred to in paragraph 25 above. The AWG-KP considered and adopted conclusions<sup>7</sup> proposed by the Chair.

##### 2. Conclusions

28. In accordance with its work programme and the conclusions adopted at its seventh session,<sup>8</sup> the AWG-KP resumed consideration of information on potential environmental, economic and social consequences, including spillover effects, of tools, policies, measures and methodologies available to Annex I Parties (hereinafter referred to as potential consequences), based on annex VI to the report on its seventh session and on submissions from Parties on this matter.<sup>9</sup>

29. The AWG-KP had a constructive exchange of views on aspects relating to potential consequences and revised the annex referred to in paragraph 28 above. The revision is contained in annex I to this document.

30. The AWG-KP agreed to resume consideration of potential consequences at its informal meeting to be held on 10–14 August 2009, based on the revised annex referred to in paragraph 29 above, and to request its Chair to revise the annex further to reflect input from the informal meeting. The AWG-KP also agreed to consider the further revised annex at its ninth session, with a view to forwarding the results of its work for consideration by the CMP at its fifth session, in accordance with its work programme.

#### **V. Other matters**

(Agenda item 5)

##### 1. Proceedings

31. The AWG-KP considered this item at its 1<sup>st</sup> meeting, on 1 June, and at its 2<sup>nd</sup> meeting, on 12 June. At the 1<sup>st</sup> meeting, the Chair of the AWG-KP proposed holding informal consultations with Parties on the working arrangements for the informal meeting to be held in August, and for its ninth session.

32. At the 2<sup>nd</sup> meeting, the Chair reported on the outcome of these informal consultations. The AWG-KP considered and adopted conclusions<sup>10</sup> proposed by the Chair.

## 2. Conclusions

33. The AWG-KP agreed that, at its informal meeting on 10–14 August 2009, it will undertake substantive discussions on item 3 (a) and (b) of the agenda of its eighth session, facilitated by the documentation referred to in paragraph 19 above and taking into account any further relevant submissions made by Parties. Acknowledging the need to reach conclusions on the scale of emission reductions to be achieved by Annex I Parties in aggregate as well as on the contribution of Annex I Parties, individually or jointly, consistent with Article 4 of the Kyoto Protocol, to the scale of emission reductions to be achieved by Annex I Parties in aggregate, it requested its Chair, with the assistance of the secretariat, to make similar arrangements for informal meetings of groups addressing issues as those at the eighth session of the AWG-KP, while bearing in mind the need to maintain a coherent approach between the Convention and the Kyoto Protocol in relation to the commitments of Annex I Parties.

34. The AWG-KP requested the secretariat, in preparing the informal meeting in August, to make arrangements for a combination of open meetings to facilitate transparency and allow for the attendance of observer organizations, and closed meetings to respect the intergovernmental character of this meeting.

35. The AWG-KP recalled<sup>11</sup> that it will consider, at its ninth session, issues relating to rules and modalities of possible improvements relating to items 3, 4 and 5 of the agenda of its sixth session, as well as any draft decisions or draft amendments.

## **VI. Report on the session**

(Agenda item 6)

36. At its 2<sup>nd</sup> meeting, on 12 June, the AWG-KP considered the draft report on its eighth session (FCCC/KP/AWG/2009/L.9). At the same meeting, on a proposal by the Chair, the AWG-KP authorized the Chair to complete the report on the session, with the assistance of the secretariat.

## **VII. Closure of the session**

37. At the 2<sup>nd</sup> meeting, on 12 June, the Chair thanked the delegates for their contributions. Statements were made by 20 Parties, including one speaking on behalf of the Group of 77 and China, one on behalf of AOSIS, one on behalf of LDCs, one on behalf of the African Group and one on behalf of the European Community and its member States.

**[Text on potential consequences for further consideration by the  
Ad Hoc Working Group on Further Commitments for Annex I Parties  
under the Kyoto Protocol at its  
informal meeting to be held on 10–14 August 2009**

**A. Basis<sup>1</sup>**

1. The Ad Hoc Working Group on Further Commitments for Annex I Parties under the Kyoto Protocol (AWG-KP) reiterated that its work on the consideration of information on potential environmental, economic and social consequences, including spillover effects, of tools, policies, measures and methodologies available to Annex I Parties (hereinafter referred to as potential consequences) should be guided and informed by [Article 4, paragraphs 8, 9 and 10, of the Convention,] Article 2, paragraph 3, and Article 3, paragraph 14, of the Kyoto Protocol and the [best] available scientific, social, environmental and economic information.

**B. Relevant decisions and Articles of the Kyoto Protocol**

2. The AWG-KP noted that according to Article 2, paragraph 3, of the Kyoto Protocol, the Conference of the Parties serving as the meeting of the Parties to the Kyoto Protocol (CMP) may take further action, as appropriate, to promote the implementation of

Option 1: the provisions of that paragraph.

Option 2: the commitment of Annex I Parties to minimize adverse social, environmental and economic impacts on other Parties of policies and measures implemented in accordance to Article 3 of the Kyoto Protocol.

3.

Option 1: The AWG-KP also noted that a framework for this process has already been established through decisions 15/CMP.1, 27/CMP.1 and 31/CMP.1.

Option 2: According to decision 27/CMP.1, the Compliance Committee shall address questions of implementation of Article 3, paragraph 14, of the Kyoto Protocol regarding potential consequences.

[The AWG-KP further noted that according to decision 27/CMP.1, the facilitative branch of the Compliance Committee is responsible for promoting compliance by Parties with their commitments under the Kyoto Protocol, taking into account their common but differentiated responsibilities, and respective capacities.

The AWG-KP noted that one way to facilitate compliance by Annex I Parties with their commitments under Article 2, paragraph 3, of the Kyoto Protocol is to enable affected Parties to submit questions of implementation of response measures to the facilitative branch of the Compliance Committee.]

### C. Framing of the work

4. The AWG-KP reiterated that further work on this issue should build on relevant decisions of the Conference of the Parties and of the CMP, and work under way by the other bodies and in other processes under the Convention and its Kyoto Protocol, with the aim of maintaining an approach that is coherent with other work in the UNFCCC process.

5. The AWG-KP noted that minimizing the adverse impacts of mitigation actions is a common concern of both developing and developed countries. It reiterated that there could be both positive and negative consequences of mitigation actions and agreed that [its work on this issue should focus on minimizing negative potential consequences for Parties, especially developing country Parties] [attention should be paid to potential negative consequences for developing countries]. The AWG-KP further noted that the work on potential consequences will need:

- (a) To support and complement efforts to mitigate climate change;
- (b) To benefit from experiences of Parties and lessons learned;
- (c) [To take into consideration the role of national [climate] policies and measures in terms of potential adverse social, environmental and economic impacts on other Parties, especially on developing country Parties;]
- (d) [To [balance the consideration of] [consider both] negative and positive potential consequences.]

### D. Vulnerability and ability to respond to the impacts of potential consequences

6.

Option 1: It recognized that potential negative consequences present challenges for all Parties.

Option 2: It recognized that although potential negative consequences present challenges for all Parties, they will be most severe for developing country Parties, in particular those identified in Article 4, paragraph 8, [and] [,] Article 4, paragraph 9, [and Article 4, paragraph 10,] of the Convention.

Option 3: It recognized that although potential negative consequences present challenges for all Parties, they will be most severe for developing country Parties, in particular for the poorest and most vulnerable developing country Parties [that are least capable to address them].

### E. Deepening understanding

7. [[The AWG-KP noted the complexity of this issue, including in the assessment of the consequences of tools, policies, measures and methodologies available to Annex I Parties.] It further noted that there [may be challenges] in anticipating, attributing and quantifying potential consequences owing to the many economic and social factors and diverse policy objectives involved. [It also noted that the potential consequences [depend on] [will be influenced by] the institutional capacity and regulatory framework in non-Annex I Parties][.]]

[and be based on evidence of actual impacts and consequences] [and be based on negative consequences that developing country Parties are facing and/or will face].

8.

Option 1: This could be achieved through various mechanisms, including regional assessments; a global assessment to be carried out by an international organization (such as the Intergovernmental Panel on Climate Change); and the regular and systematic provision by all Parties of information that is as complete as possible (including in national communications).

Option 2: The AWG-KP noted that there is a need to deepen the understanding of potential consequences and to improve the availability of evidence of actual impacts. This could be achieved through various [mechanisms] [means], including the regular and systematic provision by all Parties of information that is as complete as possible, [in particular] [including] through national communications and the regular review of this information.

Option 3: The AWG-KP noted that there is a need to deepen the understanding of potential consequences, giving priority to negative consequences on developing countries. This could be achieved through various mechanisms, including regional assessments; a global assessment to be carried out by a relevant international organization; and the regular and systematic provision by all Parties of information that is as complete as possible (including in national communications of Annex I Parties).

9. [The AWG-KP recognized that work being conducted in other forums, including on technology, may have direct benefits for addressing spillover effects.]

#### **F. Designing policies and measures**

10. The AWG-KP underlined the need for Annex I Parties [to strive] to design policies and measures carefully, in order to minimize the negative potential consequences of mitigation actions. The AWG-KP also emphasized that these policies and measures may also serve to maximize positive potential consequences. [The AWG-KP underlined the need to take into account possible interactions between different policies and measures.]

11.

Option 1: [The AWG-KP emphasized that non-Annex I Parties should strive to strengthen their institutional capacity and regulatory framework in order to minimize the negative potential consequences and maximize potential consequences of mitigation actions by Parties.]

Option 2: [The AWG-KP emphasized that Annex I Parties should support non-Annex I Parties in striving to strengthen their institutional capacity and regulatory framework in order to minimize the negative potential consequences and maximize potential consequences of mitigation actions by Parties.]

12.

Option 1: The AWG-KP agreed to [develop guidelines] [review the existing guidelines contained in decision 15/CMP.1] to assist Annex I Parties in their assessment of potential consequences [and agreed to further examine possible elements of these guidelines at its xx session].

Option 2: The AWG-KP agreed to review existing guidelines contained in decision 15/CMP.1 on the preparation of the information required under Article 7 of the Kyoto Protocol.

13. [The AWG-KP noted that one way [for Parties] to facilitate the design and selection of mitigation actions [by Annex I Parties] is to identify potential consequences [, including by the use of impact assessments,] associated with specific tools, policies and measures that are considered or implemented by Annex I Parties and then to [take them into account in finalizing these policies and

measures] [develop ways and means to minimize these consequences [on non-Annex I Parties] [on all Parties].]

### **G. Implementation**

14. [The AWG-KP noted the need for [a channel] [an expeditious mechanism] through which non-Annex I Parties could report impacts and consequences from the policies and measures of Annex I Parties on non-Annex I Parties [and the need to establish a common space where this exchange of views can take place continuously].] [Non-Annex I Parties shall provide solid information on their specific needs and concerns relating to the adverse and beneficial social, environmental and economic impacts arising from mitigation actions taken by Parties. Non-Annex I Parties shall report on impacts of response measures in their national communications. The AWG-KP agreed that the CMP should develop guidelines for non-Annex I Parties to improve reporting on those impacts.]

15.

Option 1: The AWG-KP recognized that cooperation among Parties on the further development and application of technologies could assist in minimizing negative consequences. It noted the need for technology cooperation and transfer to developing countries for the enhancement of capacities of developing countries and for finance and risk management tools, including economic diversification, to assist developing countries in assessing and dealing with potential consequences.

*{Proposal to distinguish between assessment of consequences, and ways to deal with them}*

Option 2: The AWG-KP recognized that cooperation among Parties on the further development of technologies could assist with regard to potential consequences. It noted the need for enhancement of capacities of developing countries to assess and deal with potential consequences.

### **H. Considerations on any further work**

16. [Parties noted that work on this issue should be consolidated into a single stream with a view to avoiding duplication and maintaining a coherent and consistent approach with other work being carried out under the UNFCCC process, including through the possible use of joint groups].]
