## DECISION ON THE REPORTS OF THE SUB-COMMITTEES OF THE PERMANENT REPRESENTATIVES' COMMITTEE (PRC)

## The Executive Council,

**1. TAKES NOTE** of the PRC recommendations on the Reports of its Sub-Committees, taking into account observations made by Member States;

## I. THE JOINT SITTING OF THE SUB-COMMITTEE ON GENERAL SUPERVISION AND COORDINATION ON BUDGETARY, FINANCIAL AND ADMINISTRATIVE MATTERS AND THE TECHNICAL EXPERTS OF THE F15

## ON THE 2022 AFRICAN UNION SUPPLEMENTARY BUDGET

- 2. APPROVES a total supplementary budget of US\$1,596,873 broken down below and entirely to be financed from the Reserves:
  - i) Provisional budget of **US\$375,000** for the Office of Director General so that it begins to operate while awaiting a resubmission of the proposal to be considered during the 2022 midyear budget review;
    - ii) **US\$343,554** to support the R10 activities;
    - iii) **US\$878,318.88** to cover salaries and activities of the Reforms Unit till 31<sup>st</sup> March 2023; and
      - **US\$680,000** to be used for the recruitment of an independent African Consultancy Firm.
- 3. **RECALLS** Executive Council Decision EX.CL/Dec.1074(XXXVI) para 64 in February 2020 and Executive Council Decision EX.CL/Dec.1126(XXXIX) of October 2021 recommending to the Assembly that the structure and the staffing of the AfCFTA Secretariat should be done in two phases, namely:
  - i) First Phase be initial recruitment of the Secretary General, four (4) Directors and essential staff; and
  - ii) Second phase be the positions to be filled after adoption of a permanent structure and budget, reviewing the appropriate functions of the appointed Directors and their exact number
- 4. **REQUESTS** the AfCFTA in collaboration with the Commission's department of Finance to reduce the 104 staff earmarked for recruitment in 2022 to the number that can feasibly be incorporated in the budget, and report its progress to the PRC;

5. **APPROVES** the 2021 operational balance of **US\$ 2.9 million** for AfCFTA to be carried forward to 2022 to cover expenses of the phased staff recruitment.

### II. JOINT SUB-COMMITTEE ON STRUCTURAL REFORMS AND THE SUB-COMMITTEE ON GENERAL SUPERVISION AND COORDINATION ON BUDGETARY, FINANCIAL AND ADMINISTRATIVE MATTERS

- 6. **TAKES NOTE** of the Briefing made by H.E the Deputy Chairperson regarding the progress made on the structural reforms;
- 7. **RECALLS** the Executive decision of EX.CL/Dec.1097(XXXVII) deciding that the Staff Skills Audit and Competency Assessment shall be applied to all AUC staff;
- 8. ALSO RECALLS the Executive Council Decision EX.CL/Dec.1126(XXXIX) which REQUESTED that such audit shall be performed over the same period for all Regular and Non-regular staff of the Commission excluding Elected, Political and Special Appointee Officials;
  - **DIRECTS** the Commission to present to the Policy Organs after the summit, an analysis and report on the outcome of the Skills Audit and Competency Assessment.

## THE SUB-COMMITTEE ON AUDIT MATTERS

**10. TAKES NOTE** of the Report of the PRC Sub-Committee on Audit Matters and, **ENDORSES** the recommendations contained therein.

## ON THE INTERNAL AUDIT SPECIAL REPORT ON REVIEW OF OUTSTANDING PAYMENTS OWED TO THE REPUBLIC OF SENEGAL AND THE REPUBLIC OF UGANDA

- 11. EXPRESSES concerns on the non-implementation of Executive Council decision reference number EX.CL/Dec.1057 (XXXV) and DIRECTS AUC to put in place measures to expedite the implementation of Executive Council decisions with financial obligations owed to the Member States to ensure honoring them on time.
- **12. DIRECTS** the AUC to ensure that Member States concerned with issues discussed by various PRC Sub-Committees are invited to such meetings for their inputs on required information in accordance with paragraph 5. 2 of the ToR of the Sub-Committee on Audit Matters.

- **13. DIRECTS** the AUC to put in place effective systems for early verifications of troop claims and compensation of the military equipment deployed by the Member States so as to ensure that they are compensated and paid their dues well on time
- 14. CALLS UPON the AUC to address the issues raised in the audit reports and DIRECTS as follows: -
  - 1.1. On the Obligations Owed to Senegal and its Deceased Citizens:
  - i) **RECALLS** the provisions of paragraph 22 of the EX.CL/Dec 1057 (XXXV) which instructs the Commission to verify and pay the debts due to Senegal before the end of December 2019

**REITERATES** that, AU Commission should adequately engage Troop Contributing Countries on issues concerning their troops and payments owed to them should be paid timely,

The AUC should ensure that employment contracts are clear on what is eligible to the staff on fixed and short term, including the separation packages,

**RECALLS** paragraph 43.ix of the EXCL/Dec.1126(XXXIX) and Requests the AUC to pay the dues owed to the Late Caporal-Chef Mouhamadou Abdallah NDIAYE and Requests the Commission to immediately pay the indemnities due;

**ALSO REQUESTS** the AUC to pay any other military or civilian police who saved under any other AU Missions are paid accordingly without further delay.

- vi) Additional information should be provided to the Subcommittee on the legality of AU paying the IPED staff arrears to avoid creating a wrong precedent as these occurred before the Institution was adopted by the AU,
- vii) The AUC should calculate the entire outstanding debts to all staff and creditors of IPED and submit for the consideration of the PRC Subcommittee on Audit Matters to make recommendations to PRC by May 2022.
- viii) The AUC should assist in following up the contribution areas from IPED Member States to enable the clearance of the outstanding obligations of the Institution.
- *REQUESTS* the AUC to pay without delay the compensation due to the Late Colonel Abdoul Selly NIANE and report back to the Subcommittee on

the implementation of this decision in the next Ordinary Session of the Executive Council

- x) The AUC should put in place mechanisms to ensure that once an organization is closed or/ and adopted into the AU Institutions, all staff arrears and other outstanding obligations are established, audited and timely cleared to avoid legal liabilities to the AU.
- 1.2. On Obligations Owed to the Republic of Uganda:
- i) **RECALLS** paragraph 22 of the EX.CL/Dec 1057 (XXXV) and **REITERATES** that the AUC should prioritise and make payments to the Republic of Uganda without any further delay from budget savings or other sources where funds are available under AMISOM.

**DIRECTS** the AUC to make payments to the Republic of Uganda by May 2022 and report back to the Sub-Committee on Audit Matters.

ON THE REPORT ON THE DETAILED ANALYSIS OF ALL DORMANT SPECIAL FUNDS

**5. TAKES NOTE** of the Report and **CALLS UPON** the AUC to ensure that the findings in the audit report are acted upon accordingly to enhance effective management of special funds and **DIRECTS** as follows:

The AU Commission should periodically report to the PRC and Executive Council on all special funds in line with relevant articles of the AU-FRR, these reports should include information on achievements and challenges of the funds;

- ii) The AU Commission should enhance the institutional memory mechanisms by upgrading its digital systems such that all management reports including those on Special Funds and other Funds are maintained in central portals for ease of retrieval by authorized officials, and report back to subcommittee on the progress made in this regard;
- iii) The AU Commission should ensure that audits are done at the closure of all projects so as to assess the achievement of objectives and verify the closing balances of the funds. Further audits should be done before the closure of the Dormant Funds in line with the AU rules and standard accounting practices.
- **16. APPROVES** the closure of the following seven (7) dormant Special Funds in line with the AU Financial Rules and Regulations.

ON THE OFFICE OF INTERNAL OVERSIGHT (OIO) REPORT ON AUC BUDGET PERFORMANCE FOR 6 MONTHS - JANUARY TO JUNE 2021

- **17. TAKES NOTE** of the Report and **EXPRESSES** concerns on the low rate of implantation of programmes and **CALLS UPON** AUC managers to ensure that implementation of programmes is enhanced.
- 18. RECALLS the Executive Council decisions reference numbers; EX.CL/Dec 815 (XXX); EX.CL/Dec.1031 (XXXIV) paragraph 11; 1057(XXXV) paragraph 39 (b & h); 1069(XXXV) paragraphs 10, 11, 12; EX.CL/Dec.1071(XXXV) paragraph 9; EX.CL/Dec.1073(XXXVI) paragraph 40; and EX.CL/Dec.1097(XXXVII) paragraph 18, and REITERATES that: -

i)

- AUC should take the necessary measures to reinforce the existing mechanisms for the relevant Departments to regularly submit their reports in AMERT and improve the implementation rate of the programmes during the year failing which, the AUC management shall hold accountable, as appropriate, the personnel in relevant departments responsible for underperformance, in accordance with the SRR;
- ii) Recalls paragraph 66(iii) of Decision EX.CL/Dec.1073 (XXXVI) and paragraph 39(b) of EX.CL/Dec.1057(XXXV) that directed the release and allocation of budget to be in proportion with the performance in line with the AU Golden Rules on Budgeting and an average budget execution rate of the previous three years well as implementation rate of audit recommendations,

- iii) A minimum rate of implementation threshold should also be set up and submitted for consideration by the Sub-Committee on General Supervision and Coordination on Budgetary, Financial, and Administrative Matters, so as to prevent departments from making high budget proposals and align budget proposals based on the available capacity and human resources;
- iv) Partners with low funding as compared to the pledges made should be engaged early during the budget year and strong commitments should be sought from Partners before programmes are put in budget proposals, so as to avoid budgets with funding gaps in line with Golden Rule number two (2),

The AUC should work on the AMERT system to enhance the effectiveness and efficiency of the system, and if AMERT is no longer fit for the purpose, finance should start using the project module in SAP for planning, monitoring, evaluation and reporting projects performance, or look for any other suitable system.

The AUC should develop effective mechanisms on quarterly allocation of funds and not on the current system of equal share without considering cost and size of programmes to be implemented by departments.

- **19. RECALLS** Executive Council decisions 1107(XXXVIII) and 1126(XXXIX) and **DIRECTS** the Commission to make an overall implementation report to the PRC on the implementation of the audit recommendations taken in 2021-2022 before the July 2022 session".
- 20. ALSO RECALLS Executive Council decision 1126(XXXIX) and REQUESTS the AUC to submit to the budget session for the financial year 2023 next May / June, a prior review of the rate of implementation of the audit recommendations of the AUC and AU Organs, affirming that no budget proposals will be considered if not accompanied with audit execution rates.
- 21. REQUESTS the AUC to expedite the study on the challenges causing low budget execution rate and report to PRC before the June/July 2022 Executive Council Session.
- 22. **RECALLS** section I of the Executive Council decision reference number *EX.CL/Dec 1057 (XXXV)* on the Transitional Plan and **DIRECTS** the AUC to submit a request to Policy Organs on how effective it can implement the filling of the positions in the new structure at all levels so as not to hamper the work of some departments who need more staff at lower levels than at managerial levels.

- **23. ALSO DIRECTS** the AUC to collaborate with the League of Arab States Secretariat to find alternative ways of having the work plan on Africa-Arab Partnership approved, in case of further delays in holding of Africa–Arab Summit.
- 24. FURTHER DIRECTS the AUC to provide the program implementation plan and draft plan of future programmes on AUPD-LAS for consideration of the Sub-Committee on General Supervision and Coordination on Budgetary, Financial, and Administrative Matters by May 2022.

## ON THE OIO REPORTS ON RESERVE FUND & SPECIAL FUNDS AND MAINTENANCE & WORKING CAPITAL FUNDS

25. TAKES NOTE of the Report and CALLS UPON AUC to put in place effective systems in the prudent management of Reserve, General and other Special Funds in line with AU Financial Rules and Regulations, and further DIRECTS as follows:

The AUC should ensure that the 3% is transferred from AU Acquisition of Properties Fund to AU Maintenance Fund in line with the Executive Council Decision reference number Ex.CI.877 (XXVII),

The AUC should put in place effective mechanisms to ensure that the fund balances match with the related dedicated bank balances as per required effective financial management and in line with the relevant Executive Council Decision.,

Put in place effective systems of internal controls to ensure that posting errors are eliminated on transaction postings and that approvals are sought from the Chairperson and Commissioner of Political Affairs, Peace and Security before funds in Peace Fund are used.

- iii) The AUC Leadership through the DCP should ensure management engagement in the meetings of the subcommittee with the level of Directors/Deputy Directors and Management responses are provided to all audit findings, the OIA should not submit any report without management responses for consideration by the Sub-Committee.,
- iv) A special audit engagement should be conducted to look at the persistent challenge of missing vouchers including the whole filling and archiving system so as to establish the root cause of such gaps,
- v) AUC management should ensure that monthly reconciliations on fund balances are done so as to reflect correct amounts.

vi) "Request the AUC to take, within the framework of the approved budget lines, the necessary measures for the improvement of digital documentation and archiving systems and expedite this project as a prerequisite for the traceability of internal control » so that the documents could be available on line whenever needed for audit reviews.

## ON THE OFFICE OF INTERNAL OVERSIGHT (OIO) INVESTIGATION REPORT ON ECOSOCC MEMBERS

- 26. TAKES NOTE of the Report and EXPRESSES concerns on audit findings and CALLS UPON the ECOSOCC members to operate within the provisions of the AU Legal Norms.
- 27. EXPRESSES GRAVE CONCERN on the recurring nature of the violations and lack of actions by the ECOSOCC General Assembly against those alleged to have violated Legal norms of the Union.
- **TAKES NOTE** of the Legal Brief submitted by the OLC on the legal basis for imposing sanctions against ECOSOCC members found in the report to have violated provisions of AU rules and regulations requiring professionalism, honesty, integrity and highest standard of conduct as members of ECOSOCC;
- **29. RECALLS** the Executive Council decision *EX.CL/Dec.* 1115(XXXVIII) of February 2021, paragraph 3 (ii) which requested "The Commission to conduct an independent investigation by the relevant Department of the Commission into current and future alleged violations of the African Union Code of Ethics and Conduct by members of the ECOSOCC General Assembly, and to recommend appropriate sanctions through the Bureau of the Chairperson of the Commission and Assembly decision Assembly/AU/Dec.757(XXXIII) of February 2020 which directed the Commission "...to continue to take effective actions to address all acts of misconduct in the African Union, and to use his financial and administrative statutory oversight authority over all non-Policy Organs and Institutions of the Union, including the Pan-African Parliament, the African Court of Human and Peoples' Rights, the African Commission on Human and Peoples Rights, and their elected officials."

### 30. DIRECTS the AUC Chairperson as follows: -

- To ensure that any acts of ECOSOCC members in violation of AU Legal Norms which mislead the general public and expose the AU to legal, financial and reputational risks are cancelled by issuance of public notices from the Office of the Chairperson through the OLC;
- ii) To expedite actions to prevent further damage on reputation and asset

of the Union including; to immediately and indefinitely suspend individuals found to have committed misconducts or any breach of AU legal norms including the infringement of AU Intellectual Property Rights and act of forgery;

- iii) To further communicate officially to their respective Member States to prevent the implicated individuals from participating in future activities of the Union;
- iv) To report back to the next Ordinary Session of the Executive Council on the actions taken against individual ECOSOCC members who violated the AU Legal Norms, as well as the progress made in the review of ECOSOCC legal instruments;

To send an official communication to the Permanent Mission of Federal Republic of Nigeria on the actions of the two individual nationals who have illegally acted on behalf of ECOSOCC and request for the closure of the bank account opened in the name of ECOSOCC in contravention with the AU-FRR; and to further pursue legal actions to hold accountable in accordance with the national laws of the Federal Republic of Nigeria;

To review the recommendations of the investigation to ensure alignment with the results of the in depth study on ECOSOCC;

To make official communications to Members States and the general public notifying them of the names of ECOSOCC members and other individuals who were illegally appointed to act on behalf of ECOSOCC so as to nullify their actions.

**31. INSTRUCTS** all Standing Committee members of ECOSOCC to respect the Rules of Procedure and recognize the current Presiding Officer as duly elected as the Political Head of ECOSOCC.

- **32. REAFFIRMS** that the ECOSOCC Secretariat is the sole custodian of the stamps, letterheads and related seals of ECOSOCC, and **DIRECTS** that no ECOSOCC member including the Presiding Officer should be allowed to use and keep such official symbols of the Union.
- **33. ALSO DIRECTS** all ECOSOCC members to exercise a highest degree of confidentiality in the discharge of their mandate and duties as directed in the oath of office, failing which they shall be held accountable.
- **34. RECALLS** Executive Council EX/CL 924 (XXVI) of June 2015 on the establishment of ECOSOCC National Chapters and **DIRECTS** ECOSOCC to finalise the *Framework on the National Chapters in Member States.*

- **35. ALSO REAFFIRMS** that ECOSOCC MOUs with Third Parties are initiated by the ECOSOCC Secretariat and vetted by the OLC and any MOU signed outside the required processes should be declared null and void.
- **36. WELCOMES** the election of Mr. Denise Kodhe as the Presiding Officer of ECOSOCC. **INSTRUCTS** all members of ECOSOCC to be mindful of their legal obligation and recognize Presiding Officers, duly elected as the Political Head of ECOSOCC.

On the Development of the AU Partnerships Strategy and Policy Framework

- **37. TAKES NOTE** of the progress made towards the finalization of the AU Partnerships Strategy and Policy Framework;
- **38. REQUESTS** the PRC, in close collaboration with the AU Commission, to ensure that the AU Partnerships Strategy and Policy Framework is finalized for submission to the Executive Council in June/July 2022.

- **39. EXPRESSES** Appreciation to the Government and People of Rwanda for the successful holding of the 2<sup>nd</sup> AU EU Ministerial Meeting held in Kigali, on 25 26 October 2021;
- 40. ENDORSES the Communiqué of the 2<sup>nd</sup> AU EU Ministerial Meeting<sup>1 2</sup>;
- **41. REQUESTS** the AU Commission in collaboration with the European Commission to operationalize the Ministerial Follow-up Committee for the AU-EU Partnership in consultation with member states from both sides, particularly through the subcommittee on multilateral cooperation from the AU side.

- **43. RECALLS** that participation in the upcoming 6<sup>th</sup> AU EU Summit will be in accordance with Assembly Decision Assembly/AU/Dec.762(XXXIII), of February 2020, which: "REAFFIRMS the right of all AU Member States to participate in Statutory Meetings, related to partnerships between the African Union/African Continent and another Continent or Regional Organization;

- **44. TAKES NOTE** of the work undertaken by the AU with regard to the development of the AU priorities as well as the proposals of draft working documents for the 5<sup>th</sup> Africa Arab Summit;
- **45. RECALLS** Executive Council Decision No. EX.CL/Dec.1126(XXXIX) of October 2021, which requested the PRC in close collaboration with the Commission, the General Secretariat of the League of Arab States and the host country of the 5<sup>th</sup> Africa–Arab Summit, the Kingdom of Saudi Arabia, to agree on suitable dates in May 2022, for the holding of the 5<sup>th</sup> Africa–Arab Summit and its statutory preparatory Meetings, in Riyadh, Saudi Arabia, subject to the improvement in Public health conditions caused by the COVID-19 pandemic;

- **47. EXPRESSES** Appreciation to the Government and People of Türkiye for the Successful organization of the 3<sup>rd</sup> Africa Türkiye Summit held in Istanbul, Türkiye, on 17 18 December 2021;
- **48. RECOMMENDS** to the Assembly to endorse the Outcome documents of the 3<sup>rd</sup> Africa Türkiye Summit including the "Africa-Türkiye Declaration" and the "Africa-Türkiye Partnership Joint Action Plan 2022-2026", which contains proposed actions to be implemented jointly by Türkiye, the African Union and its Member States;

- 67. Recalling also Decision No. Ext/Assembly/AU/Dec.1 (XI) of the Eleventh Extraordinary Session of the AU Assembly held in November 2018 in Addis Ababa, Ethiopia, which endorses the AUDA-NEPAD Terms of Reference and calls for the implementation of the roadmap on the clarification of the division of labour, as well as effective collaboration between the African Union, Regional Economic Communities and the Regional Mechanisms;
- **68.** Lastly, recalling the mandate given to AUDA-NEPAD by the previous decisions of the Assembly of Heads of State and Government of the AU and the Statutes of AUDA-NEPAD, to undertake "the full range of resource mobilization" as well as

## The Executive Council,

- **57. TAKES NOTE** of the Reports and the Declarations of the fourth (4th) Specialized Technical Committee on Finance, Monetary Affairs, Economic Planning and Integration, May 2021 and the second (2nd) Specialized Technical Committee on Finance, Monetary Affairs, Economic Planning and Integration held in December 2021;
- **58. COMMENDS** the STC on the deliberating on the critical theme of Developing Integrated and Complementary Value Chains for sustainable recovery and Reinforcing operationalization of the AfCFTA as the continent grapples with the adverse effects of the COVID-19 pandemic;
- **59. ADOPTS** the Reports and the Declarations of the 4<sup>th</sup> ordinary session of the STC and the 2<sup>nd</sup> Extraordinary session of the STC;
- **60. ALSO ADOPTS** the establishment of a Continental Platform on African Tax Issues to improve Domestic Resources Mobilization and fight against IFFs on the continent and requested the Commission and the stakeholders involved to

commence preparation of annual Sub-Committee meetings; **ENCOURAGES** the Member States to utilize the Sub-Committee in discussing and agreeing on a common approach when negotiating for taxing rights and issues with the international community; and **REQUESTS** the AUC, the African Tax Administration Forum (ATAF) and other relevant stakeholders to strengthen their collaboration in providing the required technical assistance to Member States to improve DRM and fight against IFFs;

- **61. ADOPTS** the Statutes of the AIMEC and **REQUESTS** the AUC to finalise the structure and the budget of the AIMEC, working with the PRC and following due process.
- 62. ALSO ADOPTS the statutes of STATAFRIC and PANSTAT; ENDORSES the Terms of reference of the establishment of the Civil Registration and Vital Statistics (CRVS) Sub-Committee and **REQUESTS** the AUC to fast track the operationalization of the Sub-Committee of the CRVS;
- **63. FURTHER ADOPTS** the Policy Framework on APRM support to Member States on Credit Rating Agencies and request the APRM and AUC to implement the support mechanisms of the Policy Framework to assist Member States to improve their credit ratings;
- **64. REQUESTS** that the final version of the draft African Principles and Guidelines on Corporate Governance, which incorporates comments should be submitted to Member States by 4 February 2022 to enable Member States at least a month before the 5th STC for our consideration and endorsement;
- **65. ALSO REQUESTS** the APRM in collaboration with AUC to resubmit the proposal for the AU annual theme, "improving access to global capital for accelerated transformative economic growth," to the Ministerial Committee on Agenda 2063, which is mandated to consider AU annual themes;
- **66. ADOPTS** the 'Strategic, Business and Operational Framework for an African Diaspora Finance Corporation' as the framework for the African Union legacy project on diaspora investment after consideration by the relevant PRC Sub-Committees;
- **67. FURTHER REQUESTS** the AUC to undertake a feasibility study on the establishment of the African Diaspora Finance Corporation (ADFC) that will cover business operations, investment planning and criteria, and the application and administration of ADFC funds;
- **68. COMMENDS** the AUC, the ATAF and the Organisation for Economic Cooperation and Development (OECD) for producing the 2021 Report on Revenue Statistics in Africa, an annual publication, which provides accurate, complete and reliable statistics on public revenues for tax policy development; and

- **69. ENCOURAGES** Member States who are not part of the Revenue statistics initiative to join, as it contributes to improving domestic resource mobilisation as set out in the African Union's Agenda 2063.
- **70. WELCOMES** with appreciation the launch of the Smart Finance and Digital Banking for MSMEs initiative which will provide access to affordable financial products and services at the grassroots level across the continent; and
- 71. ALSO ENCOURAGES the AU Commission and the AeTrade Group to promote and facilitate digital and financial inclusion in collaboration with the public and private sector, development finance institutions in Africa as well as relevant international organisations and ENDORSES the Memorandum of Understanding between the African Union and the AeTrade Group's objectives to implement digital capacity building initiatives including the Sokokuu platform as an enabler for SMES, women and youth to access regional, continental and global markets;
- 72. CONGRATULATES H.E. Hailemariam Desalegn, former Prime Minister of Ethiopia, for his appointment as the Chairman of the Board of the AeTrade Group and the foundation laid during the past three years under his leadership as the Patron.
- **73. REITERATES** our support for the replenishment of US \$93 billion to the World Bank International Development Association (IDA20) and commit to continue advocating for two thirds of the funds to be dedicated to Africa.
- VI. THE 3RD ORDINARY SESSION OF THE STC ON TRADE, INDUSTRY AND MINERALS

- **74. WELCOMES** the convening of the 3<sup>rd</sup> Meeting of the STC on Trade, Industry and Minerals held virtually on 3<sup>rd</sup> September, 2021.
- **75. TAKES NOTE** of the Report and Declaration of the 3<sup>rd</sup> Meeting of the STC on Trade, Industry and Minerals and the outcomes contained therein, as annexed.
- **76. DIRECTS** the Commission in collaboration with relevant AU bodies and stakeholders to promote the implementation of the recommendations of the Report and Declaration.
- 77. ALSO DIRECTS that the Department of Economic Development, Trade, Industry and Mining (ETIM) of the African Union Commission be renamed as "the Department of Economic Development, Trade, Tourism, Industry and Minerals (ETTIM), its Directorate of Industry Mining and Entrepreneurship(IME) to:

"DIRECTORATE OF INDUSTRY, MINERALS, ENTREPRENEURSHIP AND TOURISM (IMET)" and its Division of Industry Mining and Innovation to **DIVISION OF INDUSTRY INNOVATION AND MINERALS** in line with Assembly Decision No. Ext/Assembly/AU/Dec.1-4(XI) of November 2018 on Institutional Reform.

- 78. FURTHER DIRECTS that the STC on Trade Industry and Minerals be renamed as the STC on Trade, Tourism Industry and Minerals in line with Assembly Decision No. Ext/Assembly/AU/Dec.1-4(XI) of November 2018 on Institutional Reform and that the STC amends its Rules of Procedure to include the new portfolios on Tourism, Oil and Gas.
- **79. ENDORSES** the African Union Commodity Strategy, and Action Plan, Agenda 2063 Flagship Project under the 10 years' implementation Plan the Africa Quality Policy, the Business Plan of the African Minerals Development Center (AMDC) and the African Minerals and Energy Resources Classification Framework and Management System and the Pan African Reporting Code (AMREC-PARC).



## DECISION ON THE REPORT ON THE HUMANITARIAN SITUATION IN AFRICA

- **1. TAKES NOTE** of the Report of the Africa Union Commission on the Humanitarian situation in Africa covering the period January to December.
- 2. ALSO TAKES NOTE WITH APPRECIATION of the efforts of all Member States that are hosting refugees in their countries, in particular, the Republics of Ethiopia, Uganda and the Sudan who are hosting the largest numbers of refugees in Africa; the Islamic Republic of Mauritania for integrating refugees in the national Social Protection Program; and the Republics of Niger and Rwanda that provide an Emergency Transit Mechanism for refugees and irregular migrants from Libya, and **REMINDS** all state parties to the 1951 UN Convention on refugees, and the 1969 OAU Convention Governing the Specific Aspects of Refugee Problem in Africa, adopted by the Assembly of Heads of State and Government on 10<sup>th</sup> September 1969 in Addis Ababa, Ethiopia, of their responsibility towards international protection for persons in need of that protection as provided for in the two treaties.
  - EXPRESSES CONCERN over the continued humanitarian challenges in Africa, caused by violent conflicts, terrorist attacks, political and economic crises, adverse impact of climate change and natural disasters, such as cyclones, volcanic eruptions, drought, famine, desertification, landslides, floods, animal diseases, pest infestations, epidemics and pandemics resulting in destruction of homes, social amenities, livelihoods, food insecurity, and forced displacement. These displacements have continued to exist for protracted periods with lasting consequences on the affected populations.
- 4. RECALLS the Executive Council Decision Ex.CL/Dec.1109(XXXVIII) of the Report of the Commission on the Humanitarian Situation in Africa for the period January - December 2020 and REAFFIRMS its February 2021 decision EX.CL/Dec.1109 (XXXVIII), requesting the Commission to expedite the operationalization of the African Humanitarian Agency.
- 5. FURTHER RECALLS the Peace and Security Council Resolution PSC/AHG/COMM.1042(2021) of its 1043rd PSC meeting held at the level of Heads of State and Government on 29 October 2021 on the theme: "Addressing Disaster Management issues in Africa: Challenges and Perspectives for Human Security" and ENCOURAGES Member States to reinforce their role in humanitarian action, especially in situations of disasters and climate induced displacements.
- 6. **COMMENDS** Member States, Africa CDC and the Commission for continued support and solidarity towards refugees, asylum-seekers, and displaced persons amidst the COVID-19 pandemic and its adverse socio-economic effects on

livelihoods, especially of vulnerable populations and **CALLS** on governments to continue extending COVID-19 related measures to refugees, asylum seekers, and displaced person in accordance with its Decision EX.CL.1109(XXXVIII) adopted in February 2021.

- 7. FURTHER COMMENDS the Peace Agreement between the Republics of South Sudan and the Sudan that has enabled the return of 400,000 refugees and IDPs to South Sudan; and the Republic of Côte d'Ivoire that has achieved national reconciliation, and the conditions for a safe and dignified return of Ivorian refugees and asylum-seekers, paving the way for the invocation of the cessation clause scheduled by 30 June 2022.
- 8. **CONGRATULATES** the Arab Republic of Egypt for hosting COP27 in 2022 and **ENCOURAGES** Member States to use the platform to highlight challenges of climate change and natural disasters and their impact on displacements in Africa.
- 9. FURTHER REQUESTS the Commission to work with Member States and partners such as WFP, UNHCR, FAO among others to establish modalities of addressing food security concerns among displaced populations AND to develop operational guidelines on climate induced displacements within the context of the 1969 OAU Convention on Refugees adopted by Assembly of Heads of States on 10<sup>th</sup> September 1969 in Addis Ababa, Ethiopia.
- **10. CALLS ON** the international community to meet its international obligations of shared responsibility and burden sharing by availing much required humanitarian resources needed to support IDPs, refugees, asylum seekers and stateless persons in Africa.
- 11. WELCOMES the commitment of the Republic of Equatorial Guinea and EXPRESSES APPRECIATION for the progress made towards the organization of the AU Humanitarian Summit and Pledging Conference scheduled for 25-27 May 2022, in the city of Malabo; to raise the requisite financial resources and to seek sustainable durable solutions to the humanitarian challenges in Africa.
- 12. CALLS ON Member States, RECs, Humanitarian Partners, Private Sector, and International Community to support and participate in the Humanitarian Summit and Donors Pledging Conference scheduled for 25 and 27 May 2022 in Malabo, Equatorial Guinea as well as mobilize the necessary resources needed to implement humanitarian programs in Africa.

## DECISION ON THE PROGRESS REPORT ON THE OPERATIONALIZATION OF AFRICA CDC

- 1. **WELCOMES** the Commission report on operationalization of Africa CDC and **ENDORSES** its recommendations;
- RECALLS Assembly Decision/AU/Dec.554 (XXIV) adopted at the 24th Ordinary Session of the Assembly of the Union in January 2015 in Addis Ababa, Ethiopia, where the Assembly of the Union decided to establish the Africa Centers for Disease Control and Prevention (Africa CDC);
- **3. ALSO RECALLS** the Executive Council Decisions EX.CL/Dec.1106(XXXVII) and EX.CL/Dec.1110(XXXVIII) which **REQUESTED** and **INSTRUCTED** the African Union Commission to: "prepare a report, including a road map and Framework of Operations, outlining the financial, legal and structural implications to fully operationalize the Africa CDC in line with its Statute, for submission to the Council through the AU Policy Organs";
  - **REITERATES** its determination to strengthen the capacity and capability of Africa CDC, at both its Secretariat and Regional Collaborating Centers, for better preparedness and response to health emergencies and disease threats including the COVID-19 pandemic;
- **5. RECOGNIZES** that a strong and autonomous Africa CDC is key to protecting Africa's health, security, economic, and development agenda; and the urgency to fully operationalize Africa CDC;
- 6. FURTHER RECALLS its Decision EX.CL/Dec.970(XXXI) and CALLS FOR the implementation of 0.5% of the annual operational budget of the Union be allocated to Africa CDC as reserve funds for preparedness and response activities; and its Decision EX.CL/Dec.1106(XXXVII), for the budget of Africa CDC to be carried over to the subsequent calendar year.
- 7. **RECALLS** its Decision EX.CL/Dec.1130(XXXIX) of October 2021 and **DIRECTS** the Commission to submit the proposed amendments and recommendations together with the legal, financial and structural implications for consideration by the relevant Policy Organs via the competent Sub-Committees and STCs;
- 8. DIRECTS the Commission to put in place all necessary measures to expedite the full operationalization of Africa CDC, in line with the relevant decisions of the Policy Organs, including the completion of the implementation of the Phase I Taskforce recommendations provided there are no legal, structural and financial implications and report to the 41st Ordinary Session of the Executive Council in June/July 2022;


- **9. REQUESTS** for delegation of the Assembly authority to the Executive Council to consider and approve the amendments at its next Session,
- 10. **DECIDES** to remain seized on the matter.



### DECISION ON THE REPORT PROGRESS REPORT ON THE COVID-19 PANDEMIC AND ITS SOCIO-ECONOMIC IMPACT ON AFRICAN ECONOMIES

- 1. **TAKES NOTE** of the report which gives a general over-view of the impacts of the pandemic on African economies during 2021 and recommendations contained therein;
- 2. WELCOMES the recommendations contained in the report which are long-term and in this respect, **DIRECTS** the African Union Commission to link the recommendations to concrete short-term and medium-term projects and programmes that can contribute to the accelerated recovery of African economies from the socio-economic impacts of the COVID-19 Pandemic;
- 3. **EXPRESSES** with appreciation, the roles played by the AU COVID-19 Champion, His Excellency Mr. Cyril Matamela Ramaphosa, President of the Republic of South Africa, His Excellency Mr. Paul Kagame, President of the Republic of Rwanda, in the Partnership for African Vaccine Manufacturing (PAVM), Their Excellencies Mr. Nana Akufo-Addo, President of the Republic of Ghana and Mr. Macky Sall, President of the Republic of Senegal, in their work to develop and implement a common African position or continental framework for securing an additional US\$100 billion of the reallocated SDRs from developed countries to support the post-pandemic recoveries of African economies and put the African economies on a path of resilience;
- 4. FURTHER EXPRESSES appreciation to the African Medical Supplies Platform (AMSP) team and Africa Vaccines Acquisition Task Team (AVATT) in addressing the immediate COVID-19 vaccination ambitions, and the longer-term goal of enhanced continental vaccine supply and manufacturing;
- 5. NOTES WITH SATISFACTION progress made by the PAVM in supporting Member States to strengthen and/or establish vaccine manufacturing enterprises in Africa which will increase access to vaccines by the African population as well as contribute to increasing intra-African trade flows and in this connection, DIRECTS the African Union Commission to expeditiously implement the PAVM programmes in a collaborative manner;
- 6. **FURTHER EXPRESSES** appreciation to the African Union Commission and the Africa CDC for the continued coordination of efforts with regard to the response to the COVID-19 pandemic;
- 7. NOTES WITH GRAVE CONCERN the low rates of vaccinations against COVID-19 in some Member States and URGES for enhance sensitization for wider vaccinations as well synergizing efforts in the acquisition of COVID-19 vaccines in order to ensure universal and equitable access to vaccines;

- 8. CALLS UPON Member States to make full use of the expertise of African scientists, epidemiologists and other researchers in the Diaspora in the development of the African pharmaceutical sector in order to strengthen the Member States' capacities and capabilities to produce and procure quality and affordable pharmaceuticals, essential medicines and vaccines;
- **9. ALSO CALLS UPON** the African Union Commission to enhance efforts in domestic resources mobilization, elimination of illicit financial flows from Africa, as well as facilitating exchange of information for tax purposes and engage in the Global Tax reform discussions with the aim of maximizing African revenues
- 10. NOTES WITH CONCERN, the rising debt levels in Africa, exacerbated by the COVID-19 pandemic and in this respect, **DIRECTS** the African Union Commission to examine the available debt relief options and investment programmes which can contribute to rapid economic recovery of the economies of Member States, including developing a concept note to survey the possibility of establishing an African domestic and external debt monitoring mechanism within the African Union Commission to be considered at the next session of the Specialized Technical Committee on Finance, Monetary Affairs, Economic Planning and Integration;
- **11. FURTHER CALLS UPON** the developed countries to facilitate technology transfer and the granting of licenses that are open and non-exclusive through intellectual property rights waiver in the on-going negotiations at the World Trade Organization;
- **12. DIRECTS** the African Union Commission to submit another report on this topic for consideration by the Executive Council at its session in February 2023, complete with a status report on the implementation of this Decision.

- **1. TAKES NOTE** of the update provided by the Commission on the situation in the PAP;

- 3. DIRECTS the Commission to arrange the holding of PAP' elections by the end of April 2022;
- 4. ALSO DIRECTS the Commission to report back to the next Ordinary Session of the Executive Council;

- 3. **COMMENDS** the Commission and the African Union Development Agency (AUDA-NEPAD) on the progress made thus far towards the establishment of the African Medicines Agency (AMA);
  - **FURTHER COMMENDS** the support of the AU Special Envoy for AMA, to the Commission and for the high level advocacy efforts towards the signing and ratification of the Treaty for the establishment of the African Medicines Agency (AMA);
- 5. ACKNOWLEDGES with appreciation the World Health Organization for its continued support in the establishment and operationalization of the African Medicines Agency (AMA) both technically and financially; FURTHER ACKNOWLEDGES with appreciation the support of the Joint United Nations Programme on HIV/AIDS (UNAIDS); United Nations Children's Fund (UNICEF); the European Commission; the Bill and Melinda Gates Foundation; the United States Agency for International Development (USAID); the People's Republic of China; the Republic of Korea all other UN Agencies, donors and private sector for both their technical and financial support to the Commission in the establishment and operationalization of the African Medicines Agency (AMA);
- 6. ENCOURAGES member states that have signed on to the Treaty to ratify; and CALLS ON other member states to sign and ratify the Treaty to safeguard public health, safety and security by ratifying the AMA Treaty and operationalizing a medicines regulatory agency that will improve access to quality, safe and efficacious medicines and medical products on the continent.
- 7. FURTHER TAKES NOTE of the coming into force of the Treaty for the establishment of the African Medicines Agency (AMA) on 5<sup>th</sup> November 2021; and the offer to host the Headquarters of the African Medicines Agency (AMA) by thirteen (13) AU Member States;

- 8. **REQUESTS** the Commission to provide support to the Conference of State Parties of the AMA for the operationalization of the African Medicines Agency (AMA) at the earliest;
- **9. RECOMMENDS** that the 41<sup>st</sup> Ordinary Session of the Executive Council, take a decision on behalf of the Assembly on the host of the AMA HQ based on the recommendation of the Conference of State Parties of the AMA.

- RECALLS the decision of the 39<sup>th</sup> ordinary Session of the Executive Council (EX.CL/Dec.1132 (XXXIX) in October 2021 which adopted the theme of the year 2022 "Building Resilience in Nutrition and Food Security on the African Continent: Strengthen agriculture, Accelerate the Human Capital, Social and Economic Development";
- 2. **WELCOMES** the proposal by His Excellency Alassane Ouattara, President of Republic of Cote d'Ivoire, to include nutrition as the main theme of the African Union for 2022; and submitted by the Republic of Cote d'Ivoire for consideration by the assembly (EX.CL/1266(XXXVIII).
  - **TAKES NOTE** of the consultations held between the Republic of Cote d'Ivoire and the Commission on the re-wording of the theme of the year for 2022; upon the request of the Republic of Cote d'Ivoire
- FURTHER TAKES NOTE of the proposed wording of the theme of the year for 2022 as agreed to between the Republic of Cote d'Ivoire and the Commission.
- 5. ENDORSES the theme of the year for 2022 "Strengthening Resilience in Nutrition and Food Security on The African Continent: Strengthening Agro-Food Systems, Health and Social Protection Systems for the Acceleration of Human, Social and Economic Capital Development";

FURTHER TAKES NOTE of the activities yet to be implemented as part of the AU Theme of the Year for 2021 including the launching of the Temporary Site of the Great Museum of Africa (GMA), a Flagship Project of the AU Agenda 2063 in Algiers, Algeria and the start of its operations; the launching of the Temporary Secretariat of the African Audio-Visual Cinema Commission (AACC) in Nairobi, Kenya; The finalization of the Draft African Common Position on Restitution of Cultural Property and the Assessment on Decent Work in the Arts, Culture and Heritage and
  - **REQUESTS** Member States, Regional Economic Communities (RECs), Pan-African Cultural Institutions and partners to participate and support the launch of the Great Museum of Africa Temporary Site and the African Audio-Visual and Cinema Commission Temporary Secretariat and the finalization of the Draft African Common Position on Restitution of Cultural Property and Heritage;
  - . **CALLS FOR** the strengthening of the advocacy for the restitution of cultural property and historical heritage belonging to the continent that were illegally trafficked and looted during the colonial era and **RECOGNISES** the role to be played by the Great Museum of Africa (GMA) in this regard;
- 5. ALSO CALLS for stronger advocacy for the implementation of Assembly Decision 772(XXXIII) on Arts, Culture and Heritage which calls upon Member States to allocate at least 1% of their national budgets to the sector by 2030;
- 6. **INVITES** Member states and the AU commission to support and participate in the launch of the Grand Egyptian Museum in Egypt in 2022.
- 7. FURTHER CALLS UPON all AU Member States, Regional Economic Communities (RECs|), Pan-African Cultural Institutions, UN Agencies and partners in the arts, culture and heritage sector to continue supporting the implementation of activities and programmes in line with the AU theme of the year for 2021, since the implementation of activities on the 2021 AU Theme of the Year has been extended to December 2022.

# DECISION ON THE ACTIVITY REPORT OF THE AFRICAN COURT ON HUMAN AND PEOPLES' RIGHTS (AfCHPR)

- TAKES NOTE of the Activity Report of the African Court on Human and Peoples' Rights (the Court) for the period 1 January to 31 December 2021, and the recommendations therein; and commends the Court on the commemoration of the 15<sup>th</sup> Anniversary of its operationalization and for the work it has done over the past 15 years to develop important African human rights jurisprudence;
- 2. **RECALLS** its decision EX.CL/Dec. 1079 (XXXVI) adopted by the 36<sup>th</sup> Ordinary Session of the Executive Council held in Addis Ababa, Ethiopia, requesting the African Union Commission and the PRC, in collaboration with the Court, to undertake an in-depth study and present the legal and financial implications on the establishment of an African Judicial Network within the African Union structures.
  - ALSO TAKES NOTE of the Study presented by the Court, as well as the legal and financial implications on the establishment of an African Judicial Network within the structures of the African Union and **REQUESTS** their submission to the relevant Organs of the AU for consideration;
- **4. CALLS ON** the AUC, in consultation with the African Court, to ensure the setting up of the network and its operationalization, within a reasonable time.
  - NOTES WITH CONCERN that two decades after its adoption, only thirty-two (32) Member States of the African Union have ratified the Protocol and only eight (8) of the 32 State Parties, have deposited the declaration required under Article 34 (6) thereof, allowing individuals and NGOs to bring cases directly to the Court;
- 6. **CONGRATULATES** the thirty-two (32) State Parties to the Protocol, namely; Algeria, Benin, Burkina Faso, Burundi, Cameroon, Chad, Côte d'Ivoire, Comoros, Congo, Gabon, The Gambia, Ghana, Guinea Bissau, Kenya, Libya, Lesotho, Mali, Malawi, Mozambique, Mauritania, Mauritius, Nigeria, Niger, Rwanda, South Africa, Sahrawi Arab Democratic Republic, Senegal, Tanzania, Togo, Tunisia and Uganda.
- 7. **FURTHER CONGRATULATES** the eight (8) State Parties that have deposited the Declaration under Article 34(6) of the Protocol, namely: Burkina Faso, Gambia, Ghana, Guinea Bissau, Malawi, Mali, Niger and Tunisia.
- 8. **INVITES** the twenty-three (23) Member States that have not already done so, to accede to the Protocol, and invites the twenty (20) State Parties to the Protocol that have not yet done so, to deposit the Declaration required under Article 34 (6)

of the Protocol, and **REQUESTS** the Court to have a deeper appreciation of reasons causing Member States to withdraw their declaration required under article 34 (6) and assure Member States that such reasons are no longer there.

- 9. NOTES with concern the low level of compliance with the Court's decisions and CALLS for complete compliance with the Court's decisions and INVITES each Member State to appoint a national focal point to ensure effective follow up on all matters relating to the Court, including on compliance with the Court's decisions.
- 10. URGES the Chairperson of the AUC, in conformity with previous Executive Council Decisions, that is, (EX.CL/Dec.973 (XXXI); (EX.CL/Dec.994 (XXXII); EX.CL/Dec.1044 (XXXIV); (EX.CL/Dec.1064 (XXXV); and (EX.CL/Dec.1079), to take all necessary measures to operationalize the Legal Aid Fund, and to this end, INVITES and ENCOURAGES all Member States of the Union, as well as other relevant human rights stakeholders on the continent, to make generous voluntary contributions to the Fund to ensure its sustainability and success.
- **11. ALSO URGES** the Commission to expedite the processes of organizing the Joint Retreat between the PRC and Legal, Judicial, Quasi-judicial and Legislative Organs of the Union, with a view to considering the reform proposals for the said Organs.
- 12. EXPRESSES ITS APPRECIATION to the Government of the United Republic of Tanzania for the facilities it has placed at the disposal of the Court, and for the architectural designs for the construction of the permanent premises of the Court submitted to the AUC, and FURTHER URGES the Government of the United Republic of Tanzania, the PRC and the African Union Commission, in collaboration with the Court, working under the framework of the Task Force established by decision EX.CL/Dec.994(XXXII), to take steps to commence the construction of the Court premises.
- **13. REQUESTS** the Court, in collaboration with the PRC and the AUC, to report at the next Ordinary Session of the Executive Council in June/July 2022, on the implementation of this Decision.

#### DECISION ON THE ACTIVITY REPORT OF THE AFRICAN COMMISSION ON HUMAN AND PEOPLES' RIGHTS (ACHPR)

- **1. TAKES NOTE** of the Combined fiftieth (50<sup>th</sup>) and Fifty-first (51<sup>st</sup>) Activity Report of the African Commission on Human and Peoples' Rights (the ACHPR);
- 2. **REQUESTS** the Commission on Human and Peoples' Rights to delete the names of the countries cited in paragraph 60, B, V of the report;
- 3. **EXPRESSES** its appreciation for the efforts deployed by the ACHPR during the reporting period to promote and protect human rights on the continent, in particular in the context of the ongoing COVID-19 pandemic;
- 4. **WELCOMES** the commemoration of the 40<sup>th</sup> Anniversary of the adoption of the African Charter on Human and Peoples' Rights, under the theme: "Realities of 40 years of implementation of the African Charter on Human and Peoples' Rights and the journey towards the Africa We Want"; with various stakeholders and key actors working in the promotion and protection of human rights, throughout the year 2021;
  - **REITERATES ITS CALL** to Member States that have not yet ratified relevant human rights instruments of the African Union (AU), to do so, including the African Charter on Human and Peoples' Rights (African Charter), the African Union Convention for the Protection and Assistance of Internally Displaced Persons in Africa (Kampala Convention) and the Protocol to the African Charter on the Rights of Women in Africa (Maputo Protocol), the Protocol to the African Charter on the Rights of Older Persons in Africa, and the Protocol to the African Charter on the Rights of Persons with Disabilities in Africa;
- 6. COMMENDS State Parties to the African Charter (State Parties) that are up to date with their reporting obligations, and ENCOURAGES State Parties that have not submitted any report namely Comoros, Equatorial Guinea, Guinea Bissau, Sao Tome and Principe, Somalia and South Sudan, as well as those with more than three outstanding periodic reports to submit their Periodic Reports in compliance with Article 62 of the African Charter on Human and Peoples' Rights (African Charter), Article 26 of the Maputo Protocol, and Article 14 of the Kampala Convention;
- 7. CALLS ON States Parties to support the processes for the adoption of the Draft Protocol to the African Charter on the Rights of Citizens to Social Protection and Social Security and; the Draft Protocol to the African Charter on the Specific Aspects of the Right to Nationality and the Eradication of Statelessness in Africa;

- 8. ALSO CALLS ON State Parties to comply with the Provisional Measures requests issued by the ACHPR, and ENCOURAGES States to also implement decisions issued by the ACHPR on Communications to which they are parties, as well as recommendations following Promotion Missions and Periodic Reports, and to inform the ACHPR of the measures taken to implement those recommendations and Decisions in line with Rule 112 of the ACHPR's Rules of Procedure 2010 and Rule 114 of the ACHPR's Rules of Procedure 2020;
- 9. ENCOURAGES the PRC to work closely and monitor implementation of coordination and collaboration mechanisms between African Commission on Human and People's Rights (AfCHPR), African Court on Human and People's Rights (ACHPR) and African Committee of Experts on Rights and Wellbeing of Child (ACERWC) in view of supporting better mandate delivery by these organs and enhancing institutional coherence of the Union
- 10. **WELCOMES** the confirmation by the Republic of Rwanda to host an ordinary session of the ACHPR, when the sanitary conditions allow, and **CALLS ON** Member States, particularly those that have not yet done so, to consider hosting one of the Sessions of the ACHPR;
  - 1. REITERATES ITS CALL for the ACHPR, to implement the Executive Council Decisions: a) EX.CL/Dec.995(XXXII) relating to the review of the structure of the ACHPR to better align its composition and organogram with the mandate entrusted to it and the expansion in its work over the years; b) EX.CL/Dec.1045(XXXIV) which institutionalize an annually Joint Retreat of the PRC and the ACHPR; and c) EX.CL/Dec.1126(XXXIX) on governance matters of the Commission;
- 12. FURTHER REITERATES ITS CALL on the AUC, working jointly with the ACHPR and the Gambian Government, to implement Executive Council Decisions EX.CL/Dec.1045(XXXIV) and EX.CL/Dec. 1080(XXXVI), by establishing a Special Fund for resource mobilization, as well as taking other concrete actions required including the laying down of the foundation stone, for the construction of the ACHPR's permanent headquarters;
- **13. COMMENDS** the AUC and the R10 for facilitating and supporting the recruitment of critical staff of the ACHPR, in line with the **EX.CL/DEC.1097(XXXVII)**;
- 14. AUTHORIZES the publication of the Combined 50<sup>th</sup> and 51<sup>st</sup> Activity Report of the ACHPR; and in that regard **REQUESTS** States Parties, if they so wish, to submit, within fourteen (14) days of the date of closure of the Executive Council Session at which this Decision is adopted, their written observations on the Activity Report, to be annexed thereto upon its publication.

## DECISION ON THE ACTIVITY REPORT OF THE AFRICAN COMMITTEE OF EXPERTS ON THE RIGHTS AND WELFARE OF THE CHILD (ACERWC)

- 1. **TAKES NOTES** of the Report of the African Committee of Experts on the Rights and Welfare of the Child;
- ADOPTS the Report and commends the Committee for the work done in monitoring the implementation of the African Charter on the Rights and Welfare of the Child;
- 3. URGES Member States which have not yet ratified the African Children's Charter to expedite the ratification of the Charter; and ENCOURAGES State Parties that have entered reservation on the provisions of the African Children's Charter to consider withdrawing the same;
- 4. **CONGRATULATES** State Parties which have submitted their reports on the implementation of the African Children's Charter, and **URGES** State Parties, which have not yet reported to the Committee to comply with their reporting obligations;
- 5. **ENCOURAGES** the concerned State Parties to fully comply with the Concluding Observations and Recommendations of the ACERWC;
  - **REITERATES** the importance of the Communications procedure of the ACERWC established pursuant to Article 44 of the African Children's Charter, and call on the concerned Member States to comply with their obligations under the Charter by responding to the Committee's requests and implementing the Committee's decisions;
- 7. APPRECIATES Member States for the measures they have undertaken in commemorating the Day of the African Child for the Year 2021 on the theme- '30 years after the adoption of the Charter: accelerate implementation of Agenda 2040 for an Africa fit for children', and Encourage Member States to effectively commemorate the Day of the African Child for the Year 2022 as adopted by the Executive Council of the African Union, on '*Eliminating Harmful Practices* Affecting Children: Progress on Policy and Practice since 2013';
- 8. WELCOMES the ACERWC's report on the assessment of the impact of COVID-19 on the rights and welfare of children in Africa, and ENCOURAGES Member States to implement the recommendations of the ACERWC as indicated in the report;

- 9. ADOPTS the theme for the Day of the African Child for the year 2023 to be 'The Rights of the Child in the Digital Environment' and CALLS UPON Member States to Commemorate this day and report to the ACERWC on the theme;
- **10. WELCOMES** the development and adoption of the ACERWC's Guidelines on Child Participation, and **ENCOURAGES** Member States to make use of the content of the Guidelines in ensuring child participation and comply with their obligations under the African Children's Charter;
- 11. ALSO WELCOMES the ACERWC's General Comment No 7 on Article 27 of the African Charter on the Rights and Welfare of the Child on sexual violence against children, and ALSO ENCOURAGES Member States to make use of the principles provided within the General Comment;
- **12. FURTHER WELCOMES** the decision of the ACERWC and the ACHPR to develop the Joint General Comment on Female Genital Mutilation (FGM) and encourages Member States to cooperate with the two organs in providing information for the successful finalization of the General Comment;
  - **3. CONGRATULATES** the newly elected Members of the Bureau of the ACERWC for the period between November 2021-November 2023; and **ENCOURAGES** Member States to cooperate with the Members in discharging their responsibilities;
  - ALSO CONGRATULATES the Kingdom of Lesotho and the AUC for finalising the relocation of the Secretariat of the ACERWC; ENCOURAGES the host country to continue providing the required pursuant to the host agreement; and CALLS ON the AUC to finalise the recruitment of staff and transfer of resources for the smooth operation of the newly established Office in Maseru, the Kingdom of Lesotho.

#### DECISION ON THE ACTIVITY REPORT OF THE AFRICAN UNION ADVISORY BOARD ON CORRUPTION (AUABC)

- **1. TAKES NOTE** of the Report of the African Union Advisory Board on Corruption and the recommendations contained therein;
- 2. **COMMENDS** Cameroon for acceding to the African Union Convention on Preventing and Combating Corruption (AUCPCC).
- 3. URGES the Central African Republic to take necessary measures to complete the accession process by depositing its instrument of accession with the African Union Commission.
- 4. **NOTES** the successful completion of the review of Congo, Madagascar, South Africa and Tanzania and requests national authorities to implement the recommendations contained in the State Review Reports.
  - ALSO URGES Regional Economic Communities to facilitate the building of capacity of anti-corruption authorities through research, support to law enforcement and cooperation between national anti-corruption authorities for investigations on money laundering, asset recovery and Illicit Financial Flows. Further urges them to ensure harmonization and alignment of anti-corruption standards within their jurisdiction with the Convention.
- 6. **ENDORSES** the theme for the 2022 African Anti-Corruption Day as "Strategies and Mechanisms for the Transparent Management of Covid-19 Funds."
- 7. **REQUESTS** Tanzania to finalize the architectural drawings of the proposed permanent structure and to submit them to the Board for consideration and approval by the AU Commission.
- 8. **COMMENDS** the Government of the Arab Republic of Egypt for hosting the ninth session of the Conference of the States Parties to the United Nations Convention against Corruption (UNCAC) in Sharm El-Sheikh December 2021.

2. COMMENDS:

The Government of the Republic of Zambia for the continued support offered to the ECOSOCC Secretariat in the mobilization of the budget resources to support the renovation and upgrade of the standalone facility.

The ECOSOCC Secretariat for the progress in the development of relevant CSO policy toolkits, operational frameworks and manuals for the effective implementation of the mandate of the organ.

REQUESTS:

ECOSOCC Secretariat in collaboration with the relevant department of the Commission to finalize call for application of the 4<sup>th</sup> Permanent General Assembly of ECOSOCC during the first quarter of 2022 and ensure strict compliance with eligibility criteria of ECOSOCC membership as provided for in the Statutes of the Organ.

The Commission to undertake skills and competency based assessment on already existing staff of ECOSOCC to determine whether they meet the requirements of the revised structure of the Organ.

4. **DECIDES** ECOSOCC to undertake the recruitment of its remaining staff in the revised structure with the assistance of the Commission in line with AU Staff Regulations and Rules as well as the Merit Based Recruitment System (MBRS).

# On the In-Depth Study Report of ECOSOCC

5. RECALLS Decision EX/CL 849 (XXV) of 2014 that called for "an in-depth study regarding the functioning and performance of ECOSOCC since its inception to provide appropriate recommendations on modalities to revamp the operations of the Organ, that would help deliver on its advisory role, in line with the current reform priorities of the AU that would support the principles of African ownership".

6. TAKES NOTE of the recommendations of the ECOSOCC In-depth study report to enhance the governance and operational capacity of ECOSOCC to fully deliver on its mandate of providing advice into the policies and programs of the African Union through effective engagements with African CSOs from across the continent and in the Diaspora and directs the AUC to align the outcome of the in depth study with the recommendations of the OIO investigations.

#### 7. REQUESTS

i. The ECOSOCC, the Commission to submit the recommendations contained in the Report to the relevant PRC subcommittees for consideration.

The ECOSOCC Secretariat to work with the Office of Legal Counsel to facilitate a comprehensive and holistic review of the ECOSOCC legal instruments i.e. the Statute and Rules of Procedures in accordance with the recommendations of the Report and to submit them to the relevant PRC subcommittees for consideration.

**DECIDES** to remain seized of the matter and **FURTHER REQUESTS** the ECOSOCC Secretariat to report on progress and the implementation of recommendations of the In-Depth Study Report to the 42nd Ordinary Session of the Executive Council.

- 2. ALSO TAKES NOTE of the Report of the AfCFTA Council of Ministers;
- 3. **RECOMMENDS** to the Assembly the Draft Decision on African Continental Free Trade Area (AfCFTA) for consideration.



#### DECISION ON THE ACTIVITY REPORT OF THE AFRICAN RISK CAPACITY AGENCY (ARC)

- **1. TAKES NOTE** of the Report of the ARC Group and the recommendations made therein.
- 2. FURTHER TAKES NOTE of the efforts of the ARC Group in implementation and operationalisation of the refreshed ARC Group Strategy 2020 2024 towards ensuring that the strategy is adequate to meet the needs of Member States.
- 3. **COMMENDS** the ARC Group for the efforts to strengthen resilience in Africa against the multiple hazards and perils, coupled with the pandemic, it faces and for the extensive efforts that was directed towards accelerating and completing the development of ARC's Outbreaks and Epidemics (O&E) solution as well as for the implementation of gender sensitive and inclusive disaster risk reduction strategies.
- 4. CALLS UPON State Parties to utilize the risk financing tools and products of the ARC Group to support improving the response capacities against natural disasters and outbreaks and epidemics.
- 5. **REQUESTS** the ARC Partners to consider providing sufficient funds to sustainably cover ARC multi- year operational and programme costs.
  - **ALSO REQUESTS** State Parties to support the fundraising drive of the institution and accelerate considerations for voluntary contributions and membership fees to ARC.
- 7. **ENCOURAGES** Member States that have not yet signed and ratified the Agreement for the Establishment of the ARC Agency to consider signing and ratifying of the Agreement.

#### DECISION ON THE REPORT OF THE AFRICAN CAPACITY BUILDING FOUNDATION (ACBF)

- 1. TAKES NOTE of the ACBF annual activity report;
- 2. **COMMENDS** ACBF for championing the cause of capacity development in Africa despite the huge challenges posed by the COVID-19 pandemic;
- 3. **ENCOURAGES** ACBF to continue its mandate of capacity development across the 5 regions of the continent, the RECS and the African Union;
- **4. DIRECTS** ACBF to explore collaboration opportunities with capacity building institutions across the continent;
- 5. **REQUESTS** the ACBF to put in place Capacity building programs for diplomats posted in Permanent Missions to the African Union.
  - ALSO REQUESTS ACBF to integrate in its strategic plan studies on alcoholism and on its impact on the African societies.
  - **URGES** the AU Commission to champion the development of ACBF's Strategic Plan for the period 2023-2027 by inviting development partners for its formulation and funding;
- **INSTRUCTS** the AU Commission to implement without delay existing decisions made on ACBF Budget (Ex.CL/Dec.1073, 1107, 1126) in order to allow the ACBF to implement its mandate.

#### DECISION ON THE REPORT OF THE ITEM PROPOSED BY THE UNITED REPUBLIC OF TANZANIA ON THE INCLUSION OF KISWAHILI AS ONE OF THE AU WORKING LANGUAGES

- **1. TAKES NOTE** of the item proposed by the United Republic of Tanzania;
- 2. **RECALLS** Assembly Decision /AU/ Dec.796(XXXIV), adopted at the 34th Ordinary Session of the Assembly of the Union, held in February 2021, in Addis Ababa, Ethiopia, urging the African Union Commission to implement Assembly Decision on making Kiswahili a working language of the Union and to promote Kiswahili as a language of wider communication in Africa;
- 3. **APPROVES** and **RECOMMENDS** to the Assembly, the inclusion of Kiswahili as a working language of the Union and language of wider communication in Africa;
- 4. **DIRECTS** the Commission to work out the modalities for its inclusion in the next budget of the Commission, through the relevant subcommittees
  - **URGES** Member States and the Commission to take all necessary measures to operationalise the use of Kiswahili as a working language of the African Union and language of wider communication in Africa by July 2023 at the latest.

#### DECISION ON THE REPORT OF THE JOINT SITTING OF THE MINISTERIAL COMMITTEE ON SCALE OF ASSESSMENT AND CONTRIBUTIONS AND COMMITTEE OF FIFTEEN MINISTERS OF FINANCE (F15)

- **1. TAKES NOTE** of the Report of the Joint Sitting of the Ministerial Committee on Scale of Assessment and Contributions and the Committee of Fifteen Ministers of Finance (F15).
- COMMENDS Member States for contributing US\$178,789,441.40, equivalent to 88% of the \$203,500,000 assessed to Member States for the 2021 Regular Budget.
- 3. ALSO COMMENDS Member States for contributing US\$252,034,074.49 to the AU Peace Fund since 2017, which continues to demonstrate the high level of commitment by the Union to fully operationalize the Fund.
- 4. FURTHER COMMENDS Member States that are up-to-date in the payment of their contributions, and URGES Member States that have not yet done so to pay their assessed contributions in fulfilment of their financial obligations to the Union.
- **5. RECALLS** Decision EX.CL/Dec.1071(XXXV) of July 2019 which considered the security and political situation of Somalia and Libya and withheld the imposition of sanctions for non-payment of contributions, and which requested the Commission to consult with the two countries to agree on a payment plan to clear the arrears within four (4) years from the adoption of the Decision.
- 6. ALSO RECALLS Decisions Assembly/AU/Dec.752(XXXIII) of February 2020 which took note of the requests from Seychelles and Burundi and the challenges faced in meeting their annual contributions to the Union, and the request to the Commission to engage with Member States facing difficulties paying their contributions to the Union and those in arrears for two (2) or more years in order to agree on the payment plan for clearing their arrears.
- 7. FURTHER RECALLS EX.CL/Dec.1119(XXXVIII) of February 2021 which took note of the request from the Republic of Sudan on the need to review its assessed contribution and requested the Commission to consult with the Republic of Sudan based on the current Scale of Assessment to agree on a Payment plan to clear the arrears as soon possible, within four (4) years from the adoption of the Decision.
- 8. **RECALLS** Decision Assembly/AU/Dec.802(XXXIV) of February 2021 which endorsed the payment plans for the Republic of Somalia, Republic of Seychelles and Republic of Burundi to clear their arrears.

- 9. **COMMENDS** the Republic of Somalia, Republic of Seychelles and Republic of Burundi for fulfilling their commitments to clear their arrears in accordance with the endorsed payment plans.
- 10. ALSO RECALLS Decision EX.CL/Dec.1138(XXXIX) which urged the State of Libya and the Republic of The Sudan to conclude the engagements with the Commission to agree on their respective payment plans for settling their arrears and report back to the Executive Council in February 2022.
- 11. **TAKES NOTE** of the report of the Commission on the on-going consultations with the State of Libya and the Republic of The Sudan, URGES the two Member States to urgently finalize and submit their respective payment plans for settling their arrears to the Commission and **REQUESTS** the Commission report back to the Executive Council in July 2022.
- 12. **DECIDES** to impose sanctions on the following Member States that have fallen back on the payment of their assessed contributions:

a. Cautionary sanctions: Sao Tome and Principe, Guinea and Congo. b. Intermediate sanctions: South Sudan.

**RECALLS** Decision EX.CL/Dec.1138(XXXIX) which directed the Commission, supported by the Experts of the Committee of Fifteen Ministers of Finance (F15), to expedite the process of developing the new scale of assessment to be applied for the period 2023-2025 and present proposals for consideration and adoption by the Policy Organs in February 2022.

- 14. TAKES NOTE of the report of the Joint Sitting of the Ministerial Committee on Scale of Assessment and Contributions and Committee of Fifteen Ministers of Finance (F15) on the development of the new scale of assessments and the recommendation to give more time to the Commission and F15 Experts to gather additional data that will, in the context of COVID-19 pandemic, better reflect Member States' capacity to pay and for the necessary regional consultations to be undertaken, **RECOMMENDS** the extension of the application of the current scale of assessment 2020-2022 by one year up to 2023, REQUESTS the Commission and F15 Experts to agree on a roadmap for the development of the new scale of assessment to be applied for the period 2024-2026 and FURTHER **REQUESTS** the Commission report back to the Executive Council in July 2022.
